If a resolution is completed incorrectly (in the opinion of the scrutineer), the vote for that resolution will be invalidated.
- Step 2: **Make a copy** of this form and give it to your nominated person (proxy) to bring with them to the meeting. **Important to note:** If your nominated person (proxy) does not bring this form with them to the meeting, they cannot vote on your behalf.
- Step 3: This form must be delivered to the Secretary, (or emailed to: [manager@thecan.co.nz](mailto:manager@thecan.co.nz)) Creative Arts Napier Inc. by 4.00pm on Tuesday 30 October.

Please note the Chair of the meeting is able to act as a proxy for any member(s). If you wish to appoint the Chair as your proxy please write "the Chair" in the space provided.
