- Work should not have been exhibited before in Hawke's Bay
- Entries completed before January 2017 not accepted
- Printmaking, painting and drawing, including 3D design and sculpture, and ceramics
- Whilst CAN will take every care with your work we cannot be held responsible for any loss or damage
- Insurance of your work is your responsibility
- **30%** commission will be deducted from the retail price set by you on the application form and label
- **Maximum 3 entries** per person
- Separate application form and \$30 entry fee to be completed for each entry
- **Jpegs only for first submission by 30 April 2019**
- All work must be ready for display: pictures to be strung or fixed with large D rings , unframed works will be hung with thumb tacks
- Photography of your work is allowed during the exhibition unless you opt out.
- Your work may be used for publicity purposes unless you opt out
- Unsold work to be returned by courier will only be sent to you once CAN has received payment – you will know how much this is from your delivery charge
